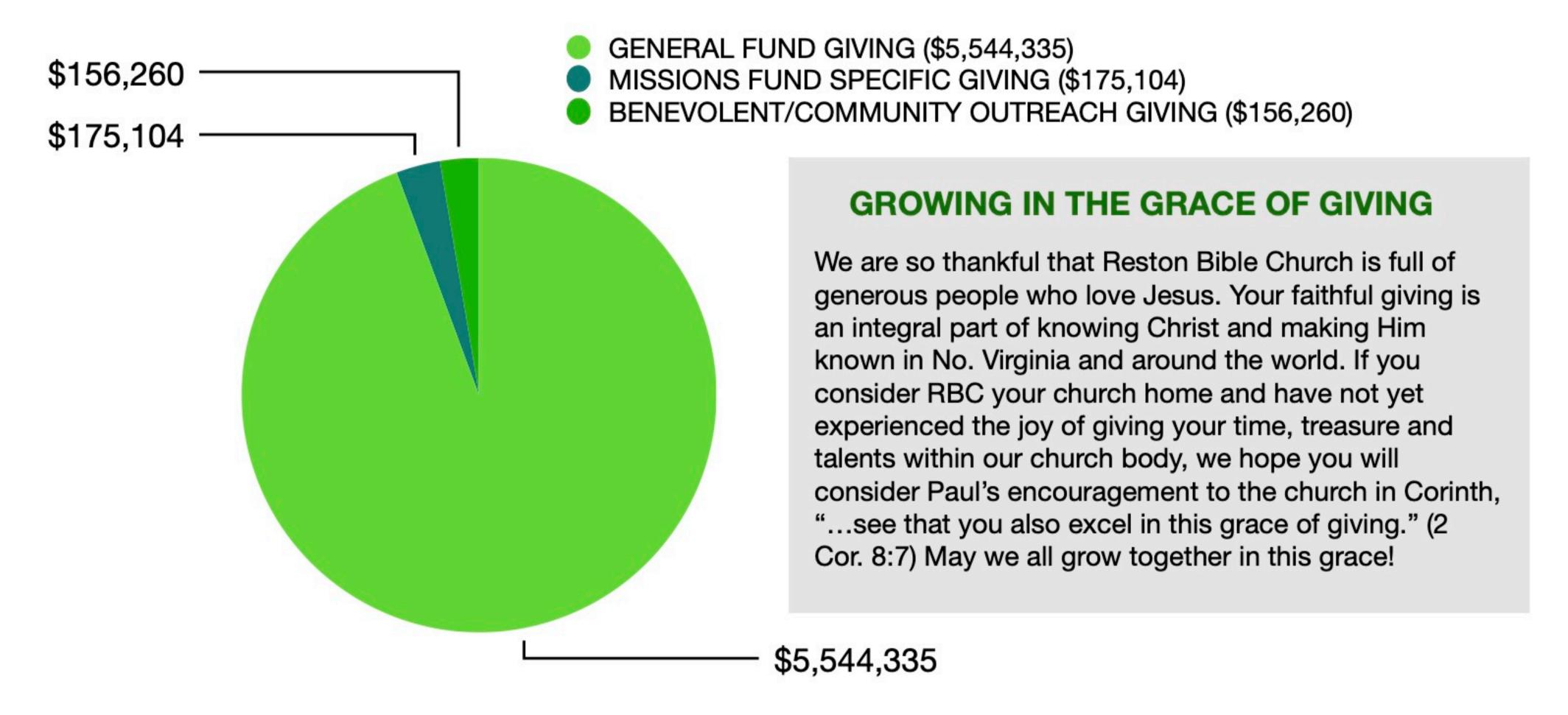
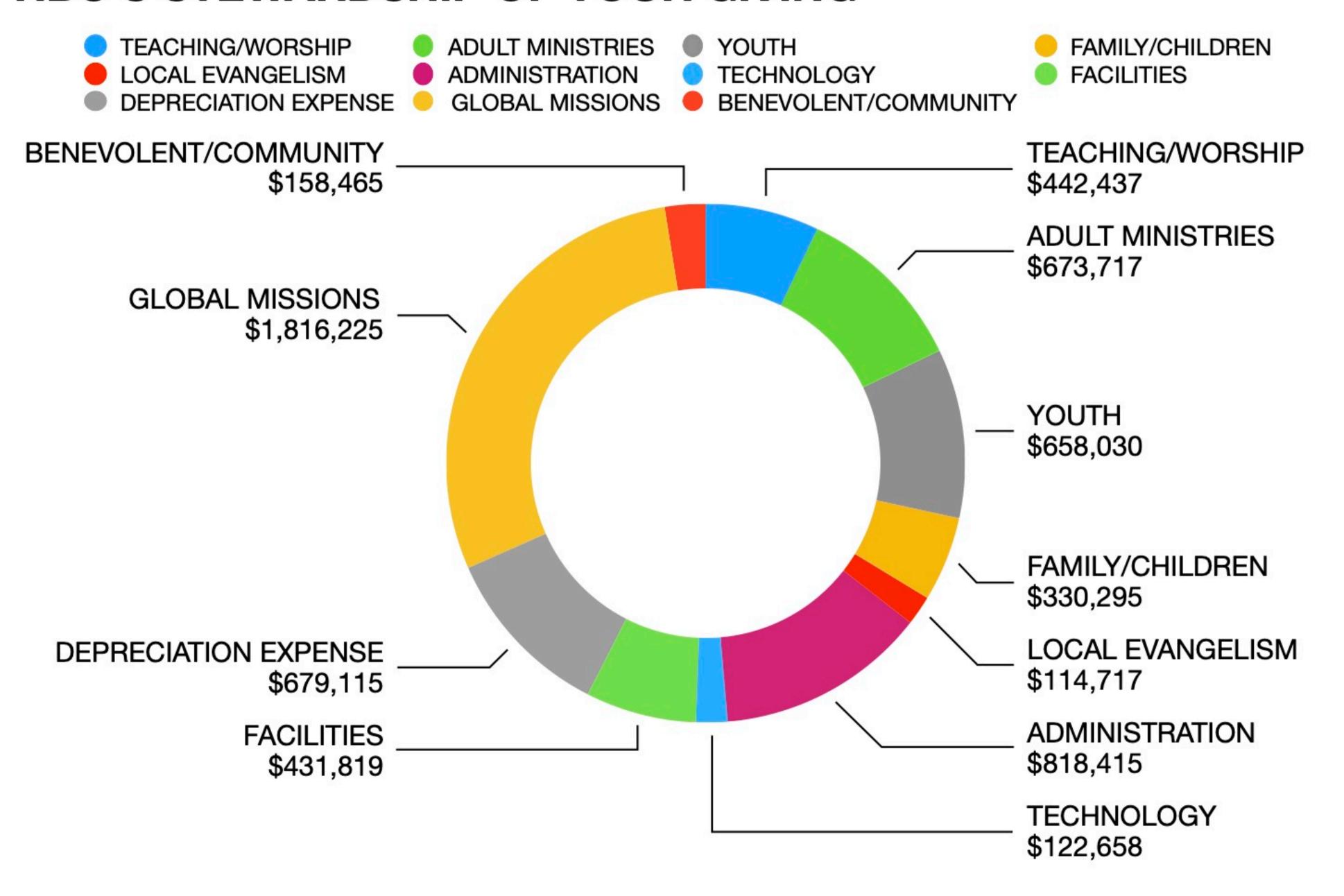

FINANCIAL FOOTNOTES

- 1. Missions Fund: This amount is in addition to the \$1.5 million allocation to Missions.
- 2. Community Outreach: In addition to donor contributions, the Food Bank is sustained by donations from Food Pantry Partners.
- 3. Global Evangelism: The General Fund supports the Global Missions budget with \$1.5 million dollars. The actual amount expended is higher due to mission trip expenses, projects, etc.
- 4. Net Gain: The net gain (surplus) went to Capital Reserves, Operating Reserves, repairs & upgrades in Youth building and small allocation to ministry needs.
- 5. The increases in the FY 25 26 ministry budgets is due to inflation, the hiring of Part Time staff and the transition of current staff into other areas of ministry.

At 8/31/25 the cash balances in the General Fund were as follows:

Operating Cash/Reserves: \$1,305,483
Designated Reserves: 229,398
Total General Fund Cash Balance: \$1,534,881

(Includes reserves for building repairs.)
